ITEM 1

Meeting called to order at 7:31 p.m.

ITEM 2

Roll Call. Present: Robin LaPage, Taylor Glantz, and Mike Lanctot Absent: Chris Juilfs and Jodie Hansen.

ITEM 3

The Chair noted the location of the Open Meetings Act and documents relevant to the meeting.

ITEM 4

No citizens had comments.

ITEM 5

No action taken on discussion with Chad Wright on new construction of duplex. This will be removed until contact is made with Chad.

ITEM 7

RESOLUTION NUMBER 20-02

WHEREAS, the Federal Disaster Mitigation Act of 2000 was signed in to law on October 30, 2000, placing new emphasis on state and local mitigation planning for natural hazards and requiring communities to adopt a hazard mitigation action plan to be eligible for predisaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, a Multi-Jurisdictional Hazard Mitigation Plan was prepared by the Lower Platte South Natural Resources District, with assistance from JEO Consulting Group, Inc. of Lincoln, NE.

WHEREAS, the purpose of the mitigation plan was to lessen the effects of disasters by increasing the disaster resistance of the Natural Resources District and participating jurisdictions located within the planning boundary by identifying the hazards that affect the Village of Alvo

and prioritize mitigation strategies to reduce potential loss of life and property damage from those hazards, and

WHEREAS, FEMA regulations require documentation that the plan has been formally adopted by the governing body of the Village of Alvo in the form of a resolution and further requesting approval of the plan at the Federal Level; and

NOW, THEREFORE, the governing body of the Village of Alvo does herewith adopt the Lower Platte South Natural Resources District Multi-Jurisdictional Hazard Mitigation Plan Update in its entirety; and

A motion by Glantz and a second by Lanctot to approve the Introduction of Resolution No. 20-02 for Adoption of the Lower South Natural Resources District Multi-Jurisdictional Hazard Mitigation Plan Update. Chair laid over approval of the Winter Delivery Option with Great Plains Service, INC for propane until more information is obtained from Great Plains. The clerk will call and get information for the next meeting.

No action taken on the removal of the tree branch West of the fire station as the branch fell to the ground in the storm. Dennis Tempelmeyer offered to cut up and haul away the branch.

ITEM 14(a) Water and Sewer Report

There is a vent that needs to be put in at the pump house. Maguire Iron did a clean out inspection. There is Public Water System Grant due September 30, 2020 and could try for funding to get the North Well fixed. A motion by Lanctot, seconded by Glantz to appoint LaPage as the first point of contact and Lanctot as the second point of contact.

ITEM 14(B) Roads Report

Robin spoke with the county about the repair to Fletcher. At this time, due to lack of funds for the village's responsibility of \$500,000 for the repair, they will continue to lay the crushed rock. The county is also looking into moving the 25 mph sign that is just west of the intersection of Fletcher and Hwy 63 back and also add a stop sign ahead sign.

Lanctot reported that the fire hydrants were flushed, and everything was good.
