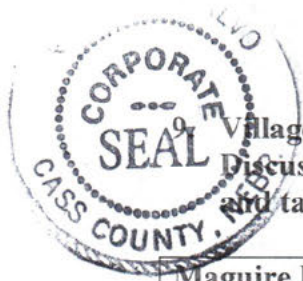
Communication of Citizens
